- 0.1. **General Information.** In this course, a co-requisite to MAE 540, Clinical Experience, we will study current issues in mathematics education. Students should become familiar with the research literature, as well as with the New York State Code of Ethics for Teachers and INTASC dispositions. Students should reflect on the implications of mathematics education research on their own classroom practices and also on the limitations of research.
- 0.2. Class Participation. This course will be conducted as a discussion, to accompany independent work by students. Students are expected to complete assigned readings prior to class meetings and contribute to the class discussion.
- 0.3. Written assignments. In addition to completing required readings, each student is expected to write one 3-4 page paper and one 8-12 page paper. The topic must be approved by the instructor, and the final paper must integrate discussion of the New York State Code of Ethics for Teachers and the INTASC dispositions.

The first paper is a *research article summary* on an approved topic of choice. For this paper each student will summarize one research article from a primary source, such as the *Journal for Research in Mathematics Education*. Further guidelines for the paper will be given in class.

The final paper is an extension of the first and should be a more in-depth discussion of the subject studied for the research summary. Each student should find at least three additional sources on the same topic. It is acceptable to include assigned class reading among the sources. Students may draw freely on the ideas and the writing in the research summary for the final paper. Further guidelines for the paper will be given in class.

Each paper should be clear and grammatically correct, and APA style (fifth edition) is required for both papers. An excellent and inexpensive reference that should help address common errors in grammar and style is:
