Course Description. This course is an introduction to Fourier series and to their use in solving partial differential equations (PDEs). We will discuss in detail the three main types of linear PDEs: the heat equation, the wave equation and Laplace's equation. These equations are fundamental in numerous applications (mathematics, physics, engineering, economics, etc.) and illustrate important properties of PDEs in general.

Prerequisites. C or higher in the following: MAT 203 or 205 or 307 or AMS 261; MAT 303 or 305 or AMS 361. Advisory Prerequisite: MAT 200. It is important to be familiar with the basic techniques in ordinary differential equations.
